### The point(s) at which fish and fish products may enter a chain of custody:

Eligible to enter into further chains of custody from the point of landing and after completion of Customs inspection.

Product is eligible for landing at the domestic port of Vladivostok. Further chain of custody certification will be required from this point onwards.

Note: for product bound for the domestic market, ownership changes when the product is offloaded in Vladivostok. However, when the product is destined for China or South Korea, ownership is taken over by a distribution company after the customs inspection in Vladivostok.
